History of Seminar Courses

Within Higher Education

History of the Seminar Course

- The importance of first-year success has long been an issue dating back to Early American Higher Ed History
 - Institutions created diverse opportunities to engage students through orientations, seminars and surveys (Gordon, 1991)
- 1888: Boston University created a freshman orientation course
 - Created to assist in the college transition





History of the Seminar Course

1911: Reed College (Portland, Oregon) created the first credit-bearing freshman orientation courses

History of Seminar Courses

- 1930s-1940s-1950s: "Adjustment" courses, not as academic
- 1960s: Some courses disappeared (Drake, 1966)
- 1970s: "New" college students (first-gen, non-traditional, and minority students) brought a need to created new courses assist students with their transition
- 1980s: 75% of American colleges offered some type of orientation course (El-Khawas, 1984)
 - Importance of seminars in assisting with student retention (Fidler & Hunter, 1986)
- Present: Seminars reflect the needs and concerns of students
 - Institutionalleadership
 - Cultural Diversity
 - Gender Equality

Seminar Courses at Temple University

Temple University Seminars

- Temple's Office of the Vice Provost for Undergraduate Studies (OVPUS) was the curricular home to all University Seminar courses.
 - Designed for each stage of the undergraduate career
 - First Year Seminar: Transition to the University
 - 1001- Introduction to rigors of university life; Academic Resources
 - 1002- Major Exploration, Career Development, Applied Learning
 - 1003- Academic Bridge for International Students
 - Sophomore Seminar: Professional planning and development
 - 2001- Career Planning and Development
 - Junior Seminar: Professional planning & post-graduate ed support
 - 3003- Staff Development Seminar (RA, OL, Greek Life)
 - Transfer Seminar: Professional planning, development
 - 2002- Planning for Success

In the Beginning....

- Advisors at the Fox School of Business taught seminar-based courses in the past
 - Business Administration 50
 - Course required by all Fox Undergraduates
 - Taught by Fox academic advisors
 - Two credit course = academically driven course
 - University Seminar 1001
 - Course in conjunction with the Fox Living Learning Community
 - Taught by 3-5 advisors
 - Approximately 60 first semester freshmen
 - Three-Four sections for Fox LLC students
 - One section for int'l students



Developing the Fox Section of UNVS 1002


- Advisor interest to development a seminar for undergraduate exploratory business students
 - Fall 2012- an email was sent out by the OSVPUS for advisors interested in teaching other sections of seminars (1002, 2001)
 - Submitted an interest to our coordinator of the LLC
 - Permission was given by supervisor
 - Found Co-Instructor
 - Set up a meeting with OSVPUS
 - Given a sample syllabus to design a business-oriented curriculum
 - Submitted syllabus for review
 - Approved and course section opened





Temple Seminar Culture Shift

- New budget model (RCM); schools/colleges started to create their own seminar courses taught by academic advisors
- Fox Four Year Leadership/Freshman Seminar Initiative Committee
 - Begin in July 2016
 - Fox advisors volunteered to join senior leadership, faculty and staff on the development of a new first year seminar course
 - Collaborated on the development of syllabus
 - Advisors were required to complete Fox Online Teaching Certificate




BA 1001 Business Seminar I

- This course provides students with the foundation necessary for success in Fox and at Temple. Students engage in interactive workshops to develop the academic, professional, and life skills required for Fox School of Business students. Topics include study habits, industry alignment, time management tools, goal setting techniques, financial literacy, embracing/understanding diversity, and university resources. Students work closely with an Academic Advisor to develop an academic plan.
- 7 Week Course

BA 1001 – Advertising

- Freshman Orientation Group Advising
- Earn 100 Fox Leadership Development Program (FLDP) points if C- or higher earned
 - Fox teamed with Suitable to gamify involvement with student professional organizations (SPOs), seminar courses and other activities within five different categories
 - Personal and Professional Development
 - Financial Literacy
 - Global and Cultural Awareness
 - Community Engagement
 - Ethics



BA 1002 – Business Seminar II

- Business Administration 1002-Business Seminar II, is a one-credit course that introduces first-year students to discover major interests through applied learning and other career-oriented experiences. The course exposes students to career paths in business and encourages major exploration through discussions with faculty, informational interviews, readings, and opportunities to practice skills needed to become more efficient students. This course will also reintroduce the rigors of higher education. Many topics covered in this course not only apply to your growth as a student, but also to your social and professional development.
- Took the UNVS 1002 for Fox students and used that as framework for BA 1002.




